## MEMORANDUM OF UNDERSTANDING

### BETWEEN

**Korean Council for University Education- Korean University Accreditation  
Institute**

### AND

**The State of Inspection for Supervision of Quality in Education under The  
Cabinet of Ministers, The Republic of Uzbekistan**

This Memorandum of Understanding is made between Korean Council for University Education - Korean University Accreditation Institute at 22~23F.Daesung DPOLIS-A 606, Seobusaet-gil, Geumcheon-gu, Seoul, Korea (hereafter referred to as “KCUE-KUAI”) and The State of Inspection for Supervision of Quality in Education under The Cabinet of Ministers, The Republic of Uzbekistan at Tashkent City, Chilanzar district, Nurkhon street, 21, 100115, Uzbekistan (hereafter referred to as “The State of Inspection”).

#### **Whereas:**

**KCUE**, established in 1982, works for the sound development of higher education in Korea by promoting inter-institutional cooperation concerning major issues common to four-year universities and colleges, and increase the autonomy, initiative, public accountability, and overall quality of higher education institutions in South Korea by making recommendations to the government and ensuring their realization in education policies.

**KUAI**, Korean University Accreditation Institute, as part of KCUE presents the standards and guidelines for quality enhancement of universities, and contributes to promoting the development of university education and producing outstanding individuals by carrying out evaluation, including the assessment and accreditation of universities.

**The State of Inspection** is currently taking unprecedented steps for development and expansion of education quality by being in charge of some tasks such as the implementation of state policy in the field of quality control of the education process, the teaching staff, and training and professional development personnel, the assignment of qualification categories to the teaching staff of the education system.



## **KCUE- KUAI and The State of Inspection**

Having similar missions and institutional objectives in the advancement of quality assurance in higher education, KCUE-KUAI and The State of Inspection now wish to start the close relationship as equal partners for the purpose of creating cooperative and collaborative mechanisms for the mutual benefit of both parties.

**HAVE REACHED AN UNDERSTANDING** as follows:

### **Article 1 Aims of Memorandum of Understanding**

Both parties have similar mission and objectives in the advancement of quality assurance in higher education, agree hereby to cooperate for the benefit of both parties and to work toward amicable, collaborative partnership to enhance quality assurance in both jurisdictions and to improve the quality of higher education in both countries.

### **Article 2 Areas of Cooperation and Collaboration**

1. Exchange of information and materials in the field of quality assurance or related concerns of interest to both parties;
  - 1.1. Documents and information related to higher education institutions in Korea and Uzbekistan
  - 1.2. Information on research projects and institutions in which each party has an interest, subject to any overriding requirements of confidentiality to which either agency may be subject
  - 1.3. Information on activities related to programs or assessments provided by KCUE-KUAI and The State of Inspection;
2. Encouragement of exchanges and visits in such categories as staff, accreditors or other specialists, when appropriate and possible;
3. Participate in seminars and academic meetings based on common interests;
4. Cooperate in any other mutually agreed activities related to quality assurance for the benefits of both parties

### **Article 3 Alternation of Memorandum**

This Memorandum is signed by both parties in a spirit of amicable cooperation. The terms of the Memorandum may be altered with the consent of both parties.

### **Article 4 Resources**

Unless alternative arrangements are specifically agreed to undertake particular activities, each party shall normally cover their own costs of implementing the terms of the Memorandum. For particular areas of cooperation, each participant will bear its own cost and expenses in



relation to this understanding.

**Article 5 Officers responsible for managing the Memorandum**

The Chairman of KCUE and President of KUAI (at the time of signing Hosung CHANG and Jong Bo YIM) and Chief of the State of Inspection (at the time of signing Tashkenbayev Ulugbek Negmatovich) will have responsibility for managing the implementation of the terms of the Memorandum. This responsibility may be delegated to relevant members of the agencies in relation to particular areas of cooperation.

**Article 6 Validity of Memorandum**

This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of five (5) years. Notwithstanding anything in this Memorandum of Understanding, either Participant may terminate this Memorandum of Understanding by notifying the other party of its intention to terminate this Memorandum of Understanding by a notice in writing at least three (3) months prior to its intention to do so. It may be extended on mutual agreement of both parties. This Memorandum will be written in Korean, Uzbek, and English. All three Memorandums are equally valid. In the event of any divergence of interpretation between any of the texts, the English text shall prevail.


